

**INFORMATION ABOUT COLLECTING, STORING AND PROCESSING PERSONAL DATA
FOR THE PREMIERE webinar “From concentrates to crops: Rethinking pig production by letting pigs forage”,
7 October 2026**

DATA CONTROLLER

The personal data of data subjects are used by CIHEAM Zaragoza based in Zaragoza - Spain, represented by the Director, who are the Data Processing Controller, in accordance with the principles of personal data protection established by the Security of the Information and Personal Data Protection Policy of CIHEAM, adopted on 5 July 2019.

SOURCE OF DATA

The personal data processed are:

- Images (photos and videos) taken during the recording of the Webinar.
- Contact details (first name, last name, email, working details, nationality, gender, connexion details) provided by the data subject during the webinar registration process.

PURPOSE AND LEGAL BASIS OF DATA PROCESSING

The data collected will be processed by CIHEAM Zaragoza and Re-Livestock partners for purposes related to the participation in the Re-Livestock webinar “From concentrates to crops: Rethinking pig production by letting pigs forage”

(7 October 2026) within the Re-Livestock project.

The data will also be used for reporting via deliverables and documents for HE European commission review, as part of the Re-Livestock project.

The legal basis for the data processing is the explicit consent of the data subject.

MANDATORY OR OPTIONAL NATURE OF DATA PROVISION AND THE CONSEQUENCES OF REFUSAL TO ANSWER

The provision of data is optional but refusal to provide data means that it will not be possible to participate in the seminar organized within the PREMIERE project.

RECIPIENTS OF THE DATA

Subject to the communications made in the fulfillment of statutory and contractual obligations, personal data of the data subjects are not subject to any form of dissemination and are processed exclusively for the purposes specified above, only by employees and/or co-workers of the data controller in their quality of persons being assigned the tasks of data processing

and/or internal processors, and by external processors authorized to process the data on behalf of the controller.

Moreover, the personal data of the data subjects could be disclosed to and processed by bodies, companies or project partner institutions, exclusively for the above-mentioned purpose. Only with your explicit consent the personal data and the images taken during the recording of the event will be published on the Institutional website, as well as in reports, publications, audiovisual presentations and in the social channels of the project and of its partners without prejudice to the personal dignity, honor and reputation of the person concerned.

STORAGE PERIOD FOR DATA

The data collected will be stored as long as necessary to achieve the purpose in question and afterwards, to fulfill legal requirements and for administrative purposes of the Re-Livestock project.

EXERCISE OF THE DATA SUBJECTS' RIGHTS

As an “Interested party” to the treatment of this data, you have the right to:

- request access, rectification, cancellation, appeal and opposition to data processing;
- obtain unhindered from the data controller the data in a structured format commonly used and readable by an automatic device to transmit them to another data controller;
- revoke consent to the treatment, without prejudice to the lawfulness of the treatment based on the consent acquired before revocation.

Any rectification or deletion or limitation of data processing made upon request of the data subjects - unless it is impossible or involves a disproportionate effort - will be communicated to each recipient to whom the personal data are disclosed. Upon request by the data subjects, CIHEAM Zaragoza may disclose the recipients of the data subjects. The data subjects can enforce all the above mentioned rights in writing at the following address:
